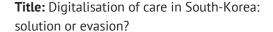

**Title:** Ethical dilemmas of datafied welfare states: a South Korean case.

Suyoung Kim will talk about four ethical dilemmas of using big data and algorithms in social welfare administration in South Korea. She will first introduce the brief history of the Social Security Information System of South Korea. Then, drawing on in-depth interviews with welfare officials, she will explore the ethical problems in data surveillance according to the PAPA (privacy, accuracy, property, and accessibility) framework. During this BOLD talk, Suyoung hopes to critically reflect the global trends toward a datafied welfare state together.

**Suyoung Kim** is associate professor of the Department of Social Welfare at Seoul National University and visiting fellow at the Leiden-Delft-Erasmus Centre for BOLD Cities.



Sochung Lee will discuss how Korea is facing many challenges and opportunities at the same time: i.e. fast population aging, high suicide rate (of all age groups) and advanced digital technology. She will start off by introducing two issues: first, social changes Korea is facing, and second, digital care services for the elderly. She will then move on to introducing some research results on the digital care services and wrap up by suggesting her personal opinion, leaving room for further in-depth discussions during the remainder of the talk.



**Sochung Lee** is assistant professor at Namseoul University in Korea. Her main research area is aging, poverty, and welfare policy in general in human care fields.
